#### Rate / Price

The unit rate to be quoted shall be unit rate and shall remain firm without the price variation clause. The biddersshould not claim for any price variation / escalation.

- The bid submitted with a price variation/escalation clause will be treated as non-responsive and rejected.
- Bid / rates quoted by the bidder shall remain valid for 120 days from the date of opening of tenders for the purpose of acceptance and award of work; validity beyond 120 days from the date of opening shallbe by mutual consent. No price variation / cost escalation is accepted.
- The rates quoted by the bidder should be inclusive of all the tax applicable, levies, excise duties, transit, insurance and freight and any other statutory levies etc.
- The Income Tax and any other taxes or charges as applicable will be deducted at source by the E.M.S Co-Operative Hospital from the successful bidder while making the payment.
- The price quoted by the bidder shall remain firm during the entire period of contract and shall not be subject to variation on any account.

#### **Execution of work**

• Time period of Supply : The successful bidder shall execute and complete the work as per specification/Scope of work mentioned in Annexure-II to the satisfaction of the Officer In-Charge within a period of **4 weeks** from the date of award of work.

- The successful bidder to whom the work is awarded, shall have to execute the work as per the work order and the terms & conditions of this Quotation document.
- The E.M.S Co-Operative Hospital is not responsible for the breakage/damage of any goods during the transit. In that case, it is the responsibility of the firm/contractor to whom the work has been awarded.
- No extra cost shall be given for transportation; cost of laborers, insurance etc., as the rates quoted isall inclusive price

#### Extension of Supply time

• Ordinarily no time extension shall be granted. However, under unforeseen site conditions, the contractor shall make proper representation to the office in-charge with reasons for the delay upon which the extension of completion time may be allowed by the office in-charge.

#### Quality assurance:

• The successful contractor should ensure the quality of material as per the requirement /discretion of the E.M.S Co-Operative Hospital and quality standards as specified by Government agencies.

#### Right to accept or reject tender

All the tenders in whom any of the prescribed conditions are not fulfilled or are incomplete in any respect shall be liable to be rejected.
