1	<p><u>Theatre Ceiling</u></p> <p>Supply & Installation of EGP steel Ceiling panels .The total panel thickness shall be of 30mm.It should be 0.8 mm+0.50mm EGP sandwich panel with a core consisting of rigid polyurethane foam, which has been injected under high pressure ,with minimum density of 40 kg/m³. The individual wall panels shall use the tongue and groove technology for joining two panels,no welding should be allowed . The gaps between panels shall be suitably filled with metal filling/epoxy and sanded flush.Steel plate finished to fine grain surface ,treated properly to take antifungal paint. Paneling should be easy to maintain, durable, antistatic /conductive and fire retardant .Clearance between ceiling panel and slab should be sufficient to allow for the installation of</p>	36	M2		

	accessories like laminair ceiling and peripheral lights etc .This closed space should be flushed continuously to eliminate dust and bacterial accumulations. Anti bacterial paint should be coated with the ceiling .It should have minimum number of junction. The junction should be seamless and should be sealed with suitable sealants.				
2	<p><u>Theatre Wall</u></p> <p>Wall painting with Anti bacterial and Anti fungal plastic emulsion paint of approved brand and manufacture to given an even shade –Two or more coats on exciting work. Corners are covered with aesthetic look, smooth round and easy to clean Aluminium coving with 3D corners. Minimum width of coving may be 100mm+-1mm.The above rate should be including material ,Labour, Scaffolding and all incidental charges.All the work should completed as per direction of our engineer in charge.</p>	72	M2

Terms & Conditions

The door shall meet the following specifications:

- Material shall be CE certified.
- Meets international quality and safety requirements as per EC Conformity Declaration & CEstandards

Rate / Price

The unit rate to be quoted shall be unit rate and shall remain firm without the price variation clause. The bidders should not claim for any price variation / escalation.

- The bid submitted with a price variation/escalation clause will be treated as non-responsive and rejected.
- Bid / rates quoted by the bidder shall remain valid for 120 days from the date of opening of tenders for the purpose of acceptance and award of work; validity beyond 120 days from the date of opening shall be by mutual consent. No price variation / cost escalation is accepted.
- The rates quoted by the bidder should be inclusive of all the tax applicable, levies, excise duties, transit, insurance and freight and any other statutory levies etc.
- The Income Tax and any other taxes or charges as applicable will be deducted at source by the E.M.S Co-Operative Hospital from the successful bidder while making the payment.
- The price quoted by the bidder shall remain firm during the entire period of contract and shall not be subject to variation on any account.

Execution of work

- Time period of completion: The successful bidder shall execute and complete the work as per specification/Scope of work mentioned in Annexure-II to the satisfaction of the Officer In-Charge within a period of **4 weeks** from the date of award of work.
- The successful bidder to whom the work is awarded, shall have to execute the work as per the work order and the terms & conditions of this tender document.
- The E.M.S Co-Operative Hospital is not responsible for the breakage/damage of any goods during the transit. In that case, it is the responsibility of the firm/contractor to whom the work has been awarded.
- No extra cost shall be given for transportation; cost of labourers, insurance etc., as the rates quoted is all inclusive price
- The contractor shall have to bring all the supporting materials for carrying out the above work.

Extension of work completion time

- Ordinarily no time extension shall be granted. However, under unforeseen site conditions, the contractor shall make proper representation to the office in-charge with reasons for the delay upon which the extension of completion time may be allowed by the office in-charge.

Quality assurance:

- The successful contractor should ensure the quality of material as per the requirement

/discretion of the E.M.S Co-Operative Hospital and quality standards as specified by Government agencies.

Right to accept or reject tender

- (i) The right of acceptance of Quotation will rest with the E.M.S Co-Operative Hospital
- (ii) The acceptance of the tender shall rest with the E.M.S Co-Operative Hospital who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason. Further, the E.M.S Co-Operative Hospital reserves the right to accept the whole or any part of the tender and tenderer shall be bound to perform the same at the rates quoted. All the tenders in whom any of the prescribed conditions are not fulfilled or are incomplete in any respect shall be liable to be rejected.

Insurance

Contractor shall at his own expenses carry and maintain insurance with reputable Insurance Companies for :-

- (i) Employees State Insurance Act,
- (ii) workmen's Compensation & Employer's Liability Insurance,
- (iii) Any other Insurance required under Law or Regulations or by Owner.

Safety Regulations

Contractor shall adhere to safe construction practice and guard against hazardous and unsafe working conditions and shall comply with safety rules. The E.M.S Co-Operative Hospital shall not be held responsible for any accidents that occur due to unsafe practice of the persons employed by the contractor to carry out the work.

Payment terms

A part payment up to 20% of the contract value shall be paid upon receipt of the materials required for project at the site after due verification and authentication by the Officer In-charge against submission of the part bill by the contractor. Balance Payment shall be made against the final bill within 45 days from the date of completion of the works to the satisfaction of the E.M.S Co-Operative Hospital /Officer In-charge in all respects and submission of completion certificate.

Other Important conditions

Before submitting their bid proposals, bidders shall carefully examine the site of the work to familiarize themselves with the site conditions which exist regarding present work to be executed,

materials to be matched,precautions required, working space available and other conditions necessary to the making of the intelligent bids. All the above terms and conditions of the tender as mentioned above AND included in the tender documentis duly accepted.
